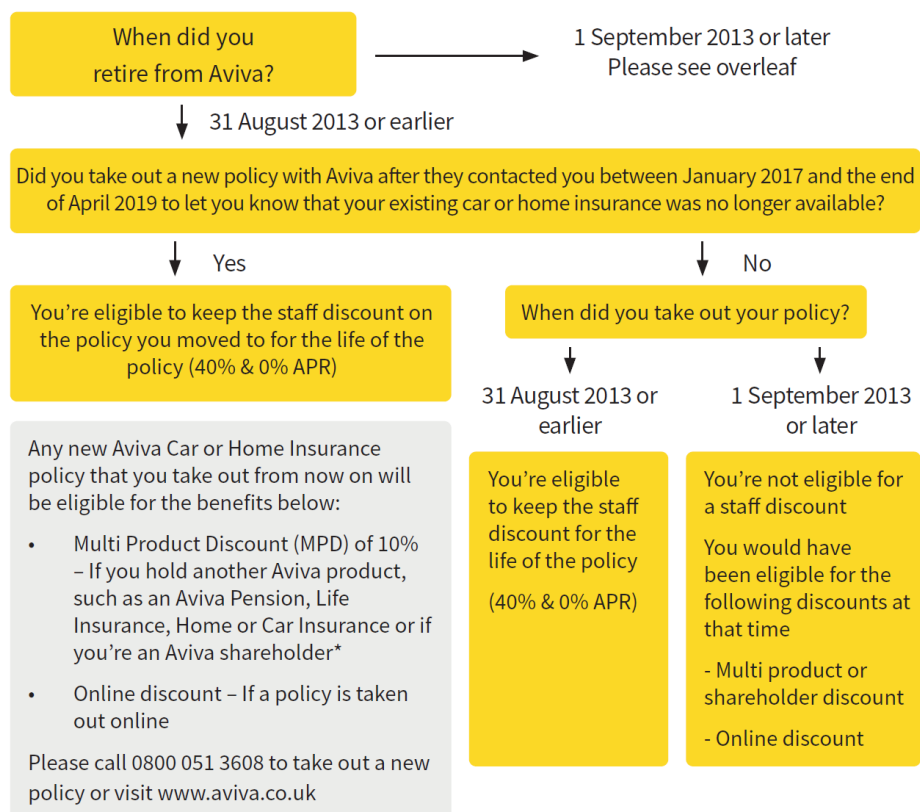
Car and Home insurance discounting approach for retired Aviva staff

*10% discount on car insurance doesn't apply to extra protection and courtesy car, existing car and van customers aren't eligible as they receive a multi-car discount instead when they add a car to their existing policy.
